THE BOARD OF DIRECTORS OF PERTAMINA (PERSERO)

- Considering : a. That for the purpose of enhancing company image and
 - giving added value for all stakeholders, the code of
 - conduct in the business relationship between the company
 - and its business partners should always be maintained in
 - order it is in line with the principles of Good Corporate
 - Governance in a consistent and sustainable manner and
 - in accordance with the business practice which
 - continuously evolves.
 - b. That the acceptance, giving, or exchange of gifts/souvenirs in a business relationship is something common, but potentially it would create a conflict of interest and it is contrary to the company values in addition to the fact it would potentially create legal issues

- c. That the development in the business communities nowadays demands a proactive response from the company to maintain a good business relationship with the partners and remain in the ethical corridor and GCG, therefore it is deemed necessary to make an adjustment with the gratification provisions applicable in the company, in this case the Guidelines for the Acceptance and Giving Gifts/Souvenirs and Entertainment No. A-001/N00300/2009-SO.
- d. That Pertamina employees have several reporting obligations, the compliance of which needs to be maintained and the previous reporting guidelines have to be adjusted in connection with the revisions made on the other related guidelines.
- e. That the whistle blowing system owned by the company and has been effectively functioning as the facility or

system in providing care and fulfilling aspirations which is secure, responsive, transparent, accountable and responsible, should be implemented consistently and improved continuously; for that purpose it is deemed necessary to adjust the Organizational Work Procedures (TKO) No. B-001/N00300/2008-SO on Whistle-Blowing System (WBS) Management according to the current development.

f. That the Decree of the Board of Directors No. Kpts-082/C00000/2009-SO dated 5th October 2009 on the Acceptance and Giving Gifts/Souvenirs and Entertainment as well as Whistle Blowing System (WBS) is deemed no longer suitable with the current company business development.
